HOW TO ENTER: No purchase necessary to register. Register at USPBL games at Jimmy John's Field now until midnight Sunday, August 27, 2023. Fans will scan the QR code that will take them to a landing page to fill out a form to enter for the chance to win. Or fans can click the landing page link in various social media posts or eBlast communications. Or they can mail a postcard to Metro Detroit Chevy Dealers USPBL Bullpen Warmup Giveaway c/o Strive Creative at 23510 Woodward, Ferndale, MI 48220. All mailed entries must be received on or by August 26, 2023.

WINNER SELECTION: **Prizewinners:** Ten (10) Prizewinners will be randomly selected from all the entries received at various times throughout the USPBL baseball season. Each prizewinner will have 24 hours from notification to respond and accept his/her prize. If he/she fails to respond or refuses the prize, it will automatically be forfeited. Another randomly selected prizewinner will then be chosen and will have 24 hours from notification to respond. This process will continue until each of the ten (10) prizewinners are officially named.
