HOW TO No purchase necessary to register. You must be at least 18 years old to enter,

PARTICIPATE: a Michigan resident and able to provide valid photo identification upon

participating. Enter to participate at each Wayne State University (WSU) home

football game at a TBD location.

PARTICIPANT SELECTION & LOGISTICS:

Each contestant will be selected by random drawing of all entries submitted for each home football game. Contestants must be present in order to participate. There will be one randomly chosen contestant per Wayne State University (WSU) home football game. Contestants will be chosen by a representative of WSU or the Association and will be contacted via phone or text at each home football game after the first quarter. Each contestant must kick or punt a standard NCAA football of regulation size and weight into the bed of a Chevrolet Silverado from a distance of 35 yards. Each contestant will be allowed a maximum of one (1) kick attempt. No practice or warm-up kicks may be made under any circumstances. The football must enter the Silverado truckbed on the fly and come to rest inside of the truckbed to be considered a winning attempt. The ball may not bounce into or out of the truckbed. A kicked ball that bounces, deflects, or otherwise come into contact with any object, person, or surface prior to entering the truckbed is automatically disqualified. A kicked ball that makes initial contact with the inside surface of the truckbed and subsequently bounces out of the truckbed and onto any other surface or portion of the truck is not eligible to be considered a winning kick. Once the ball makes contact with any object, person, or surface, the ball will not constitute a winning kick under any circumstances. When kicking the ball, the football must be held by an individual from WSU on the ground or a simulated holding device (which is approved by the Administrator). No tees of any sort may be used. No aid of any kind may be given to the contestant participating in these events. Nothing may be done to the football, Silverado, contestant's footwear or playing surface that would enhance the contestants' chances of successfully completing the kick. Once selected as a contestant, he or she may not re-select anyone else to kick for him or her.

GRAND PRIZE: \$5000.00 (less federal and state taxes of 25%) if the kick is successful. If the kick does not land in and stay in the Chevrolet Silverado truckbed the contestant will receive a \$100 gift card to the Wayne State Athletics Team Store just for participating.

CONTEST RULES
