**Age Requirements:** Kids must be in the age range of 8-14 years old

**Code of Conduct and Guidelines:**

- Arrive 15 minutes prior to youth clinic time.
- Bring your glove.
- If you are on a baseball team, feel free to wear your uniform. Otherwise, dress comfortably in clothes that allow you to move around.
- All participants' parents or legal guardians must sign a liability waiver when checking in.
- No outside food/beverage/containers are allowed at any youth clinic.
- No weapons or pets are allowed at any youth clinic.

If there is inclement weather and USPBL determines that it is unsuitable for these clinics, they will be rescheduled. Participants will be notified as soon as possible.
